Initiatives 2008-10

SLA A/S has elected company safety representatives and made a survey among all employees about physical and psychical aspects of their work. Furthermore we have engaged with a physiotherapist to ensure the best possible working conditions for all employees.

When thousands of COP15 delegates arrived at the climate summit in the Bella Center, they were not bored in the queue. SLA had staged the arrival area with a temporary urban space that provided food for thought. With the project White Balance it is SLA's intention to put focus on the factors in our cities related to the climate issues pivotal to COP15.

Stig L. Andersson: "The city is an ecosystem where each part is interdependent. Nature and city are not opposites, but merely different systems, that as a whole must be in balance. COP15 will affect the possibility for a future balance between human urbanization and Earths resources. The arrival area at COP15 will hopefully inspire to this thinking."

SLA has been the head of a team, which participated in the development of Ballerup Center. The task was to enhance the experience of the city center and to lay the foundations of a development where human health and an active city life is central. Team SLA response is a concept we call Ballerup Campus City. We have developed a planning tool called process urbanism. It regards the city as a part of the natural ecosystem and vice versa. There has been an active process involving the town's citizens in three workshops where they were briefed on the status of projects and was able to comment on this and engage in dialogue with team members.



ODENSE KNOWLEDGE AND RESEARCH PARC

Area: 37 ha.

By situating the entire built-up area to the east, the best possible contact with the infrastructure is secured; an important aspect of making the area more sustainable. There is also a close connection with the University of Southern Denmark Odense, the Killerup village and the Rosengårdcenteret shopping centre as well as to the recreational sports areas and golf courses. The western part of the landscape along the protected wood is kept free of buildings. This area has magnificent views of the Funen landscape with the fringe of the wood and untouched trees.
